

Privacy Policy

Introduction

Employee Benefit Funds Administration Ltd. (herein referred to as "EBFA") is committed to safeguarding your trust by protecting your privacy and personal information. We have prepared this privacy policy to outline how and why we collect your personal information, how we protect that information, and how you can submit an inquiry or file a privacy or personal information related complaint. This privacy policy applies to all personal information that is collected by EBFA, including information you provide to EBFA through our website, www.ebfa.ca (the "Website"), including in our online portal for members (the "Member Portal"), and information we collect from third parties where you consent or we are permitted by law to do so.

In order to ensure that we meet our commitment to you, we have prepared this privacy policy in compliance with the *Personal Information Protection Act*, commonly known as *PIPA*, and the *Personal Information Protection and Electronic Documents Act*, commonly known as *PIPEDA*.

As a user of the Website and by you voluntarily providing any of the requested information to access and use our Member Portal, you are expressly consenting to the collection and use of your personal information and you are bound by this privacy policy, as may be amended from time. Any amendments to this privacy policy are effective immediately upon being posted and your continued use of the Website or the Member Portal will constitute your agreement to abide by the policy, as modified.

Note that this privacy policy was last updated on January 1, 2022.

Why We Collect and Store Personal Information

In order to effectively manage the pension, health & welfare and education benefits, including the use of the Website and the Member Portal, we require access to your personal information, which may include, but is not limited to, name, email address, residential address, telephone number, Social Insurance Number, employer information, employment history, as may be applicable, and log data, including but not limited to your computer's internet protocol ("IP") address, your internet service provider, the pages on the Website you visit, and the time and date of your visit to the Website or Member Portal. We will retain such personal information as long as is reasonably necessary.

The personal information you provide may be used by EBFA and shared with EBFA employees and professionals retained by EBFA to assist in the administration of member benefits for the following purposes:

- to update your personal and contact information with EBFA;
- to permit access to Claim History and other information;
- to maintain appropriate business records;
- to provide you with EBFA services, including the proper management and administration of benefits;
- to provide you with EBFA online services, including the Website and the Member Portal;
- to respond to your questions and comments;
- to send you any EBFA communications you have opted-in to receive;
- to conduct marketing and surveys compliant with Canadian anti-spam legislation;
- to tailor your user experience or troubleshoot any problems associated with your use of the Member Portal;
- for security purposes, such as the prevention of potentially prohibited or illegal activities;
- to meet any legal or regulatory requirements;
- to take any action required or permitted by law;
- to enforce Website and Member Portal Terms and Conditions;
- for statistical analysis, including the use of Google Analytics; and
- as otherwise described to you when you provide us with your personal information.

EBFA will not transfer or disclose your information to third parties unless such transfer or disclosure is required to provide you access to EBFA services, including use of the Website and Member Portal. Where EBFA is required to share your personal information in order to provide you with access to such services, we will ensure that any third parties receiving such information are bound by this privacy policy and have safeguards in place to protect your personal information and privacy.

By you providing this personal information to us voluntarily, you expressly consent and otherwise agree to how EBFA shall use and share your information as outlined in this policy, on the Website and Member Portal.

We will also use your personal information to verify your identity when you contact us, as is required by *PIPA* and *PIPEDA*.

EBFA does not sell, rent, or share the information of members to third parties for marketing or commercial purposes, and your personal information will not be accessible by other members using EBFA services, including the Website and Member Portal.

How We Protect Your Information

At EBFA, we strive to protect your personal information from loss, theft, and unauthorized access by taking appropriate technical measures such as the use of secure servers, firewalls, and data encryption. We also work hard to ensure that our employees understand our obligations to you with respect to safeguarding your privacy. Please note that while the security of your personal information is of paramount importance to us, we cannot guarantee absolute security as no method of storing or transmitting electronic data is perfectly secure.

Accessing and Updating Your Personal Information

We rely on you to provide accurate personal information and to notify us of any changes. This helps us ensure that the information we have is as accurate and up to date as possible.

You have a right to access and update your personal information, and can easily do so in the Member Portal. Please note that deleting your personal information or providing inaccurate personal information may preclude you from using some EBFA services. We would also be happy to provide a copy of your personal information in another format outside of the Member Portal, as required under *PIPA* and *PIPEDA*. To obtain a copy of your personal information, please see "How to Contact EBFA with Questions, Concerns, or Complaints" below. Note that you will need to provide us with information sufficient to verify your identity as we will not otherwise release your personal information.

Cookies and Links to External Websites

While using the Website, a "cookie" text file may be placed in the browser directory of your computer's hard drive. These files allow websites to store a small amount of information on a web browser to be retrieved at a later time, when the site is visited again. You may set your browser to reject all cookies, though some pages of our website may not function optimally as a result.

The Website provides links to other entities including but not limited to IBEW Local 424, the Electrical Industry Training Centre and the Electric Contractors Association of Alberta, which are operated by third-parties not under our control. This Privacy Statement does not describe the privacy policies of any third-party websites or their privacy practices. EBFA is not responsible for how such third-parties collect, use or disclose your personal data, so it is important to familiarize yourself with their privacy policies before providing them with your personal data.

What to do if you have a complaint?

As part of our commitment to protect your security and privacy, we have established the complaint process outlined below in compliance with *PIPA* and *PIPEDA* requirements.

- Send your security and privacy related complaint to our offices using the contact information provided above.
- We will provide you with a response confirming your complaint within 2 business days of receiving it at our offices.
- We will then contact you within 14 business days to obtain further information regarding your complaint.
- Next, we will conduct a thorough and detailed investigation.
- After completing our investigation, we will contact you and communicate our findings and results. Within 30 days of receiving your original complaint, we will notify you of either the results of our completed investigation or the need for an extended investigation, the results of which will be communicated to you no later than 60 days after we received your original complaint.
- We will then take remedial steps necessary to address the problem.

If, despite our best efforts, we have not provided a satisfactory response to your complaint, you may wish to contact either the Information and Privacy Commissioner of Alberta at oipc.ab.ca or, alternatively, the office of the Privacy Commissioner of Canada at http://www.priv.gc.ca/
